

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF ROCWELL GATE LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the following Articles of Amendment are submitted for the purpose of amending the Articles of Organization of Rocwell Gate LLC (the "Company").

ARTICLE I NAME
