**ARTICLES OF ORGANIZATION  
OF  
WENTZEL FAMILY, LLC**  
(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Act").

1. **NAME**. The name of this limited liability company (the "Company") is **WENTZEL FAMILY, LLC**.

2. **DURATION**. The period of duration of the Company shall be perpetual.




