The street address and the mailing address of the principal office of the Company are 1655 Prudential Drive, Apartment 1511, Jacksonville, Florida 32207.


ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS


**CERTIFICATE OF DESIGNATION
