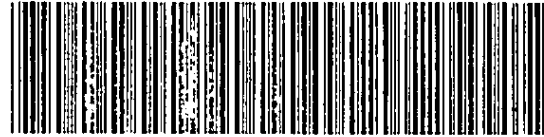




## ARTICLE IX - MANAGEMENT

## ARTICLE X - AMENDMENT

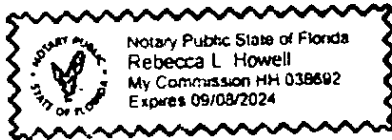

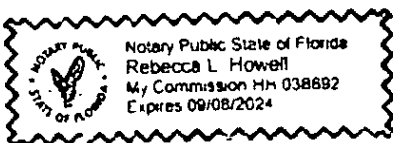
