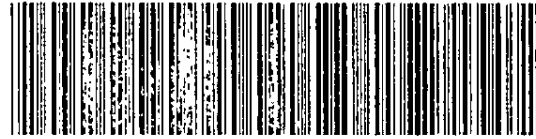

ARTICLE I - NAME

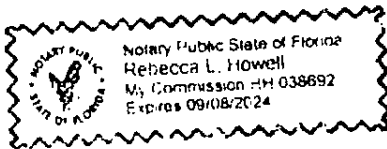



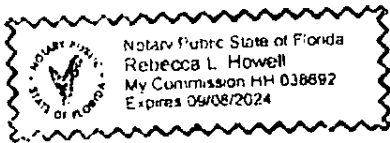
