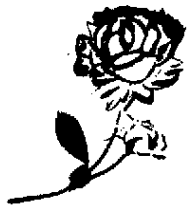


The two LLC's indicated above are both reinstatements by the original filer. Pleaser reinstate both companies as originally requested on your website.
