**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
CONTINENTAL-NATIONAL ASSOCIATES, LLC**

Continental-National Associates, LLC, a Florida Limited Liability Company (the "Company"), whose Document Number is L23000246359 and whose Articles of Organization were filed on May 18, 2023, hereby certifies as follows:

1. The Articles of Organization of the Company are hereby amended by deleting the present form of Article I, in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Continental-National Associates, LLC (the "Company"). The Company's principal address is 4007 W Obispo Street, Tampa, Florida 33629, and the Company's mailing address is P.O. Box 18385, Tampa, Florida 33679.
