The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or upon a plea of "no lo Contendere" or its equivalent, shall not in itself create a presumption that the person did or did not act in good faith and in a manner which he reasonably believed to be in the Company, and, with respect to any criminal action or proceeding, had reasonable cause to believe that his/her conduct was lawful
