**ARTICLE 1  
NAME**

The name of the company is Solid Legacy, LLC (the "Company").

**ARTICLE 2  
DURATION AND PLACE OF BUSINESS**

The period of duration of the Company is perpetual and its principal place of business is at 407 Lincoln Road PH-NE, Miami Beach, Florida 33139.
