**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Rack'Em Up Sports, LLC (the "Company"). The Company's principal and mailing address is 808 South MacDill Avenue, Tampa, Florida 33609. The Company's initial registered agent is David M. Jeffries, whose address is 1227 N. Franklin Street, Tampa, Florida 33602. 


