
D3TTAN LLC was authorized to conduct business in the State of Florida, and was administratively dissolved by the State of Florida on April 15th 2023.

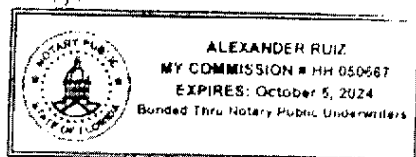
D3TTAN LLC makes this affidavit in support of allowing a new entity to take the D3TTAN name on a Florida LLC.
