**ARTICLES OF ORGANIZATION

The undersigned, Michael Riggle, a natural person competent to contract and an authorized representative of a member of B & B Woof Pack, LLC, hereby presents these Articles of Organization as the Articles of Organization of B & B Woof Pack, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is B & B Woof Pack, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company's initial principal office is 755 Grand Blvd, 105B-182, Miramar Beach, FL 32550. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**

The Company shall be managed by a manager in accordance with the terms of the Operating Agreement of the Company. The name and address of the initial manager of the Company is as follows:




