**ARTICLES OF ORGANIZATION

The undersigned, Robert Dickhaus, a natural person competent to contract and an authorized representative of Live Oak Farm Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of Live Oak Farm Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Live Oak Farm Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS




