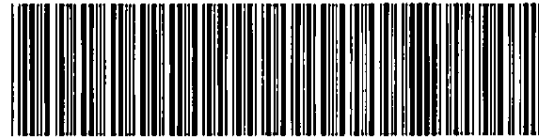



Management






