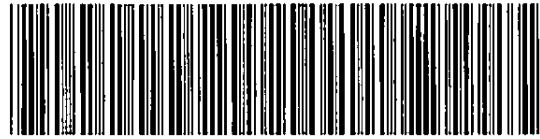

THIRD: The mailing and street address of the principal office of the Limited Liability Company is 19771 Quisto St, Venice, FL 34293.




