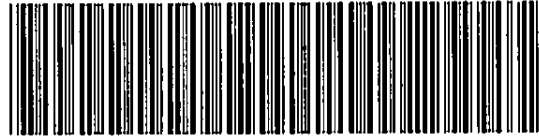



**ARTICLE I.

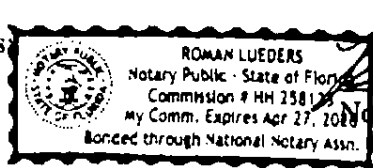
