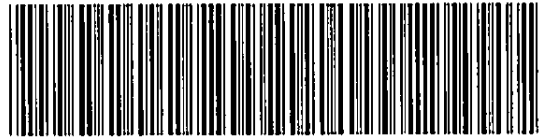

The Company is to be a manager-managed company. The initial manager of the Company shall be:




