ARTICLES OF ORGANIZATION OF PROPER SUPPORT, LLC

The undersigned, being the sole member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act. Chapter 605, Florida Statutes, do hereby adopt the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is PROPER SUPPORT, LLC (the "Company").

ARTICLE II ADDRESS

The principal place of business and mailing address of the Company is:

ARTICLE III REGISTERED AGENT AND OFFICE

The power to adopt, alter, amend, or repeal an Operating Agreement of the Corngany shall be vested in the Managers of the Company in the manner set forth in the Operating Agreemen of the Company, if any.
