# ARTICLES OF ORGANIZATION OF SWEE PEA FARMS, LLC

## <u>ARTICLE I – NAME</u>

The name of the limited liability company is Swee Pea Farms, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
