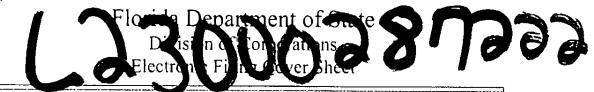

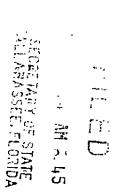

ARTICLES OF ORGANIZATION LAKE DORA PARK, LLC

Article I Name

The name of this limited liability company ("Company") is LAKE DORA PARK, LLC.

Article II Address

The mailing address of the Company is P.O. BOX 86, OKAHUMPKA, FL 34762. The street address of the Company's principal office is located at 2005 AUSTIN MERRITT ROAD, GROVELAND, FL 34736.

Article III Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

Article IV Purpose and Powers

This Company is organized with a general business purpose, and has all powers provided by law and may use those powers for any lawful purpose.

Article V Registered Agent

The name of the Company's initial registered agent in Florida is ZACHARY T. BROOME, ESQ., BOWEN|SCHROTH, P.A. The address of the Company's registered office in Florida is 600 JENNINGS AVENUE, EUSTIS, FL 32726.

Article VI Management

The Company will be managed by a Manager, as further provided in the Company's Operating Agreement. The initial manager(s), who shall serve until the earlier of their deaths, resignations, replacements or until the first annual meeting of members and their successors are elected and qualified, shall be: WILLIAM MARK MERRITT.

Article VII Admission of New Members

Members of the Company have the right to admit new members. Members may admit to the Company additional members to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the members. Admission of any such additional members requires the written consent of all members then having any ownership interest in the Company. Any additional members are allocated gain, loss, income, or expense by the method provided for in the Operating Agreement of the Company, and if no method is specified, then as may be permitted by the Internal Revenue Code of 1986, as amended.

Article VIII Continuation of Business

The remaining members of the Company have the right to continue the business on the death. retirement, resignation, bankruptcy, or dissolution of a member or the occurrence of any other event that terminated the continued membership of a member of the Company. The business may be continued only on the unanimous consent of the remaining members.
