**ARTICLES OF ORGANIZATION
OF

The undersigned, Donald Keith Phillips, a natural person competent to contract and a member and authorized representative of Old Corry Field Properties, LLC, hereby presents these Articles of Organization as the Articles of Organization of Old Corry Field Properties, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Old Corry Field Properties, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE VI - MANAGEMENT


