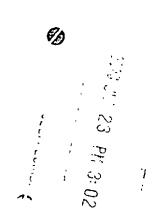

ARTICLES OF ORGANIZATION FOR FAMILY DOUGH, LLC, A FLORIDA LIMITED LIABILITY COMPANY
