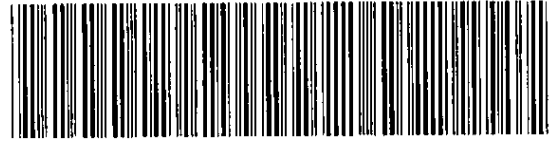

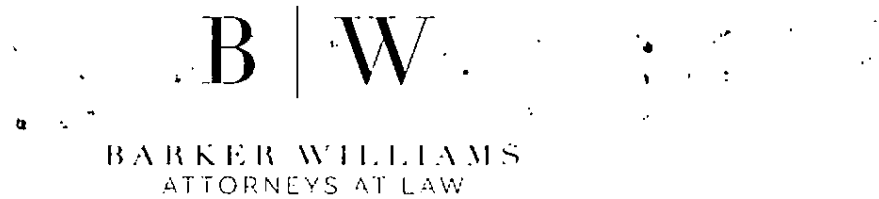

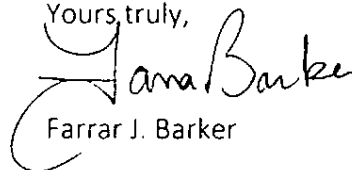

These Articles of Conversion and the attached Articles of Organization are submitted to convert GoodVibe, LLC, a Colorado limited liability company (the "Converting Entity"), to a Florida limited liability company in accordance with Section 605.1045, *Florida Statutes*.

1. The name of the Converting Entity immediately prior to filing of these Articles of Conversion is GoodVibe, LLC.

2. The Converting Entity is a limited liability company first organized under the laws of the State of Colorado on April 12, 2021.

3. The name of the Florida limited liability company as set forth in the attached Articles of Organization is GoodVibe 30A Luxury Concierge, LLC (the "Converted Entity").
