**ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION  
OF  
CR DOLPHIN SQUARE LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **CR DOLPHIN SQUARE LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

**FIRST:** The Articles of Organization of **CR DOLPHIN SQUARE LLC** were filed with the Florida Department of State on June 27, 2023 and assigned document number L23000306908.

**SECOND:** The Company's Articles of Organization are hereby amended by deleting Article VI of the Articles of Organization and replacing it in its entirety with the following new Article VI:


**"ARTICLE VI. MANAGEMENT"**
