



### ORGANIZATION FOR AVIS HUNT HOLDINGS, LC, A FLORIDA LIMITED LIABILITY COMPANY

#### ARTICLE I. NAME

The name of the Limited Liability Company is "Avis Hunt Holdings, LLC" (the "Company").
