**ARTICLE I.  
NAME**

The name of the Limited Liability Company is "*Avis Hunt Holdings, LLC*" (the "*Company*").

**ARTICLE II.  
ADDRESS**

**ARTICLE III.  
DURATION**

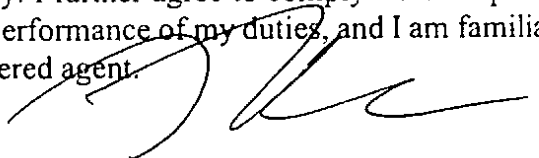
