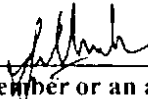

Articles of Organization

The purposes for which GIZSA Enterprises, LLC is organized are:

1. To import from and export to Canada, Mexico and any other countries of the world, marketable goods, materials, and services subject to governmental rules and regulation.
2. To purchase, take, receive, lease as leasee, take by gift, devise, or bequest, or otherwise acquire, and to own, hold, use, and otherwise deal in and with any real or personal property, or any interest therein, situated in or out of this State, which may be appropriate to enable the corporation to accomplish any or all of its purposes.
3. To sell, convey, mortgage, pledge, lease as lessor and otherwise dispose of all or any part of its property and assets.
4. To acquire and to own real property, improved or unimproved.
5. To purchase, take, receive, subscribe for or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, loan, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations, of, other domestic or foreign corporations, associations, partnerships or individuals.
6. To make contracts and incur liabilities; to borrow money for its corporate purposes at such rates of interest as the corporations may determine without regard to the restrictions of any usury law of this State; to issue its notes, bonds, or other obligations and to secure any of its obligations by mortgage, pledge, or deed of trust of all or any of its property, franchises and income.
7. To conduct its business, carry on its operations, and have offices within and without this State and to exercise in any other state, territory, district or possession of the United States, or in any foreign country, the powers granted by this Act.
8. To act as agent/broker and/or consultant for any corporation, partnership or individual conducting business in the United States of America for business transactions in Asia, Europe, North and South America and any other parts of the world.
