

- 1. Name, Jurisdiction, and Type of Entity of the Converting Eligible Entity. - 5. <u>Appraisal Rights</u>. The Converted Eligible Entity has agreed to pay any members having appraisal rights the amount to which such members are entitled under Sections 605.1006 and 605.1061-605.1972, Florida Statutes.
- 6. <u>Effective Date</u>. This conversion shall be effective when these Articles of Conversion are filed with the Florida Department of State, Division of Corporations.
