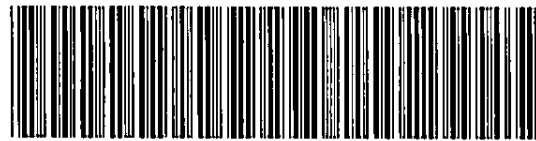





ARTICLE III - DURATION


