**ARTICLES OF ORGANIZATION
OF
CERRO AZUL INVESTMENT LLC**

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Cerro Azul Investment LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal office and mailing address of the Company is 3350 SW 148 Avenue, Suite 140, Miramar, Florida 33027.

**ARTICLE III

DURATION AND CONTINUATION

ARTICLE VI
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII
