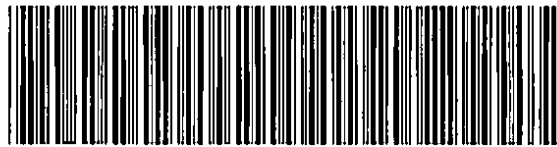

The Limited Liability Company's principal address will be 4301A 34th Street North, Saint Petersburg, FL 33714.

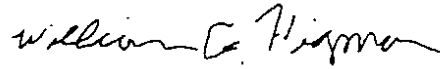

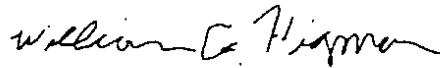

The name of the limited liability company is Fiberglass Coatings, LLC.

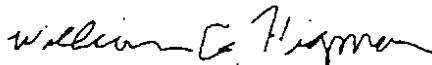

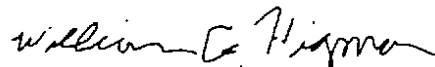
