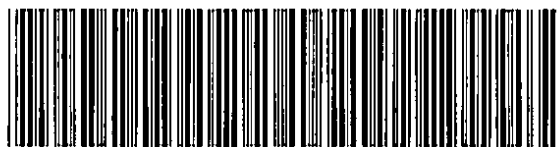

**ARTICLE I
NAME**

The Company's existence shall commence effective as of July 18, 2023 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.


**ARTICLE IV


