updating the RA address and the two Managers address on this submission.

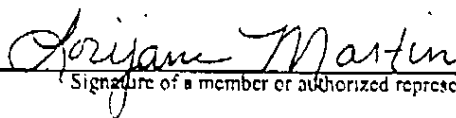
