**ARTICLES OF ORGANIZATION
OF
US CUBA MARITIME SERVICES, LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is US Cuba Maritime Services, LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 701 Brickell Avenue, Suite 3300, Miami, FL 33131.

ARTICLE III. REGISTERED AGENT AND OFFICE
