**ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION
OF
COASTLAND SWEETWATER LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **COASTLAND SWEETWATER LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of **COASTLAND SWEETWATER LLC** were filed with the Florida Department of State on July 21, 2023 and assigned document number L23000347092.

SECOND: The Company's Articles of Organization are hereby amended by deleting Article VI of the Articles of Organization and replacing it in its entirety with the following new Article VI:
