
ARTICLE IV



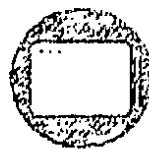
