# Articles of Organization of THE BEACH BLUE-TIQUE L.L.C.

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the Limited Liability Company is THE BEACH BLUE-TIQUE L.L.C.

#### ARTICLE II - DURATION

The period of duration of the Limited Liability Company shall be from the date of filing until the first to occur of the following:




