# ARTICLES OF ORGANIZATION IMAGINE KISSIMMEE CHARTER ACADEMY, LLC

These Articles of Organization ("Articles") are adopted and effective this 25<sup>th</sup> day of July, 2023, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

#### ARTICLE I

The name of the Limited Liability Company is Imagine Kissimmee Charter Academy, LLC (the "LLC").

### ARTICLE II ADDRESS

The mailing address and principal office of the LLC is: 2850 Bill Beck Boulevard, Kissimmee, Florida 34744.

## ARTICLE III MEMBERSHIP AND FORM OF MANAGEMENT

The LLC shall be Manager-Managed within the meaning of Section 605.0407, Florida Statutes, and have a single member consisting of Imagine Schools Non-Profit, Inc. (the "Member"). The Member is a Federal Tax-Exempt Entity. The LLC shall not admit any additional members at any time. The LLC shall be governed by the Act, these Articles, and the Operating Agreement, of even date herewith.

#### ARTICLE IV PURPOSE

The general purpose of this LLC shall be to operate exclusively for charitable, educational, scientific, or literary purposes, and in furtherance of such goals is authorized to do any and all activities which it is empowered to do under the Articles and the Operating Agreement, provided, however, that nothing herein shall be construed as allowing any activities which would jeopardize the LLC's derivative tax-exempt status or the tax-exempt status of the Member or would otherwise be inconsistent with the Member's classification as an organization described in §501(c)(3) of the Internal Revenue Code of 1986, as amended or replaced from time to time (the "Code") and its regulations as they now exist or may hereafter be amended, or as a corporation, contributions to which are deductible under §170(c)(2) of the Code. The specific purpose for which the LLC is formed is to establish, develop, maintain, improve, manage, and otherwise operate one or more public charter schools and associated uses.

# ARTICLE V INITIAL REGISTERED AGENT

The name and address of the initial registered agent of the LLC is Cogency Global, Inc., 115 North Calhoun St., Suite #4, Tallahassee, FL 32301.

#### ARTICLE VI AMENDMENTS OR RESTATEMENTS

Any amendment or restatement of these Articles of Organization shall be in writing and shall not be effective unless and until approved in writing by the Member and the LLC. No oral representations by the Member or the Managers shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, these Articles of Organization.
