*Name*



*Authority & Purpose*

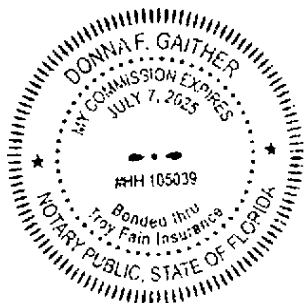


