ARTICLE I – NAME

The name of the limited liability company is Love Sam, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE VI – MANAGEMENT

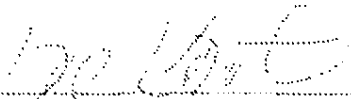

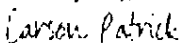
