**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **TRUE CYPRESS, LLC** adopts the following Articles of Amendment to its Articles of Organization:
