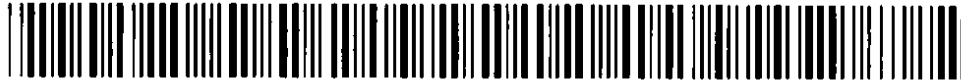

ARTICLES OF ORGANIZATION

THESE AMENDED & RESTATED ARTICLES OF ORGANIZATION (the "Amended & Restated Articles") of VICKERY PARKE LLC, a Florida limited liability company (the "Company"), are submitted in accordance with §605.0202 of the Florida Revised Limited Liability Company Act (the "Act") for purposes of amending and restating the Articles of Organization of the Company in their entirety. From and after the date of filing hereof, the Amended & Restated Articles shall be as set forth in Article SECOND below.

FIRST: The information required by §605.0202 of the Act is as follows:



The Company is created pursuant to Chapter 605, Florida Statutes, and shall be governed by the laws of the State of Florida.


