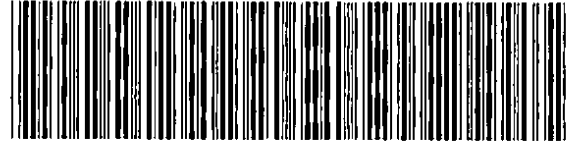

**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
Name**

The name of the limited liability company is RF Miami LLC (hereinafter called the "Company").


