ARTICLES OF ORGANIZATION σf CUMBERLAND RENTAL PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act. Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE 1

NAME

The name of the limited liability company shall be Cumberland Rental Properties, LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 12850 Mistletoe Place, Jacksonville, Florida 32246.

ARTICLE II

PURPOSES AND POWERS
