RESOLVED, that Article I of the Articles of Organization of the Company shall be amended its entirety to read as follows:

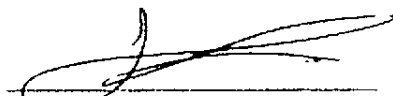
**ARTICLE I - NAME OF THE LIMITED LIABILITY COMPANY**
