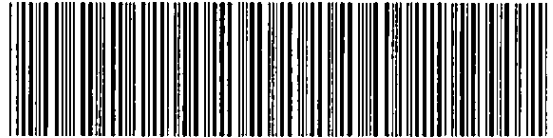

ARTICLE V – Limitation on Agency Authority of Members:

Pursuant to section 605.04074 of the Florida Revised Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.

ARTICLE VI – Operating Agreement:

Any Operating Agreement (as defined in Section 605.0102(45) of the Act), relating to this Limited Liability Company must be in writing and signed by all of the members.

ARTICLE VII – Liability of Member; Indemnification:

(a) Liability of Member. Except as otherwise required in the Act, the debts, obligations, and liabilities of the Company, whether arising in contract, tort, or otherwise, shall be solely the debts, obligations, and liabilities of the Company, and the Member shall not be obligated personally for any such debt, obligation, or liability of the Company solely by reason of being the Member or participating in the management of the Company.

(b) Indemnification. To the fullest extent permitted under the Act, the Member (irrespective of the capacity in which it acts) shall be entitled to indemnification and advancement of expenses from the Company for and against any loss, damage, claim, or expense (including attorneys' fees) whatsoever incurred by the Member relating to or arising out of any act or omission or alleged acts or omissions (whether or not constituting negligence or gross negligence) performed or omitted by the Member on behalf of the Company; provided, however, that any indemnity under this Section shall be provided out of and to the extent of Company assets only, and neither the Member nor any other person shall have any personal liability on account thereof.


ARTICLE VIII – Effective Date of Existence:

The effective date of existence of this Limited Liability Company shall be the date of filing of the Articles.

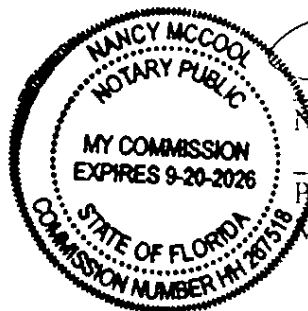


