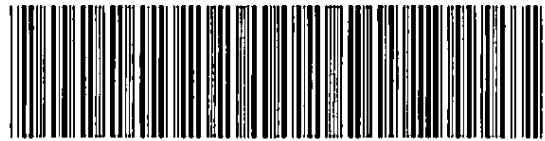

**ARTICLE II – ADDRESS:**


