ARTICLES OF ORGANIZATION

The undersigned, desiring to amend the Articles of Organization for SEASTATE LANDSCAPING LLC, a Florida limited liability company, under and pursuant to Chapter 605, Florida Statutes, does hereby adopt the following Articles of Amendment to the Articles of Organization for such company:

1. The Articles of Organization for Seastate Landscaping LLC were filed on August 9, 2023 and assigned document number L23000374042.
2. The following amendments to the Articles of Organization were adopted by the limited liability company on even date herewith by all of the Members of the Company by a unanimous Action by Written Consent in lieu of a meeting of the Members as permitted by Florida Statutes, such vote being sufficient for approval:
 - a. Article I is hereby deleted in its entirety and replaced with the following:

ARTICLE I. NAME

The name of this company shall be SEASTATE LAND SERVICES COMPANY, LLC; and shall be referred to herein as "the Company" or "this Company."


- b. Article IV is hereby deleted in its entirety and replaced with the following:
