**ARTICLES OF ORGANIZATION
OF
C.R.C. BUILDERS VENTURES, LLC**

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the “Company”) shall be:

C.R.C. Builders Ventures, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and mailing address of the Company shall be:

Odessa, Florida 33556

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 17510 Boy Scout Road, Odessa, Florida 33556, and the initial registered agent of the Company at such office shall be Christopher J. Farrar. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Management

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Manager shall be as set forth in the Operating Agreement of the Company, and any successor or replacement managers shall be as set forth in the Operating Agreement of the Limited Liability Company.

Operating Agreement

ARTICLE VII

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
