

ARTICLES OF CONVERSION

to

THIS IS TO CERTIFY THAT:

Article I

Ground Zero Crypto, LLC is a Maryland limited liability company formed on February 18, 2022 (the "Converting LLC") and, by virtue of these Articles of Conversion, is converting (the "Conversion") to Ground Zero Crypto, LLC, a Florida limited liability company formed under the laws of the State of Florida (the "Converted LLC"), on the terms and conditions set forth herein.

Article II

The terms and conditions of the Conversion were advised, authorized, and approved by the Converting LLC in the manner and by the vote required by Md. Code Ann., Corps. & Ass'ns § 4A-1102.

Article III

The terms and conditions of the Conversion were advised, authorized, and approved by each member of the Converting LLC as required by Fla. Stat. Ann. § 605.1045(2)(c).

Article IV

The version of these Articles of Conversion that is filed with the Florida Department of State will be accompanied by the Converted LLC's Articles of Organization, attached as **Exhibit** 1, as required by Fla. Stat. Ann. § 605.1045(2)(d).

Article V

There are four (4) members of the Converting LLC. Each member owns an equal membership interest. As such, the Converted LLC shall issue four (4) equal membership interests, and the members of the Converting LLC shall each receive one (1) membership interest in the Converted LLC.

Upon the completion of the Conversion in accordance with the Maryland General Corporation Law ("MGCL") and the Florida Revised Limited Liability Company Act ("FRLLCA"), the Converted LLC shall continue as the same entity as the Converting LLC, and the Conversion will have the effects set forth herein and in the MGCL and the FRLLCA.

Article VI

The principal office of the Converted LLC shall be located at 5422 First Coast Highway, Suite 116, Fernandina Beach, Florida 32034.

Article VII

The registered agent in the State of Maryland for the Converted LLC shall be Registered Agents. Inc., 5000 Thayer Center, Suite C, Oakland, Maryland 21550.

Article VIII

These Articles of Conversion shall become effective on July 21, 2023.

Article IX

The undersigned acknowledges these Articles of Conversion to be the act and deed of the Converting LLC and, further, as to all matters or facts required to be verified under oath, the undersigned acknowledges that, to the best of their knowledge, information and belief, these matters and facts relating to the Converting LLC are true in all material respect and this statement is made under the penalties of perjury.
